Who can receive CSFP?

- Residents of Charleston, Beaufort, Berkeley, Dorchester, Georgetown, Horry, or Williamsburg counties.
- 60 years of age or older
- Must meet the income guidelines created by USDA

How to apply:

- Contact or visit your local distribution site
- Complete CSFP application at site
- Provide proof of age (ID)
- Provide proof of address (ID, bill)
