Items in the monthly box include: canned fruit, vegetables, meat, cereal, juice, and cheese

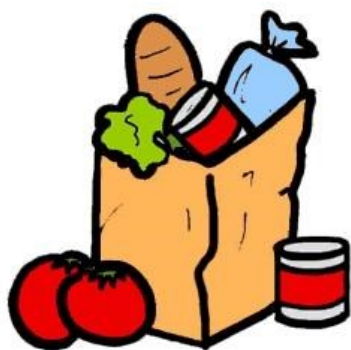

Who can receive CSFP?

- Residents of Charleston, Beaufort, Berkeley, Colleton, Dorchester, Georgetown, Jasper, Horry, or Williamsburg counties.
- 60 years of age or older
- Must meet the income guidelines created by USDA

How to apply:

- Contact or visit your local distribution site
- Complete CSFP application at site
- **Provide proof of age and address (ID)**

The letter must contain the complainant's name, address, telephone number, and a written description of the alleged discriminatory action in sufficient detail to inform the Assistant Secretary for Civil Rights (ASCR) about the nature and date of an alleged civil rights violation.
