### What is CSFP?

The Commodity Supplemental Food Program (CSFP) is a USDA nutrition program that offers FREE monthly nutrition information and nutritious foods.

**Items in the monthly box include:** canned fruit, vegetables, meat, cereal, juice, and cheese

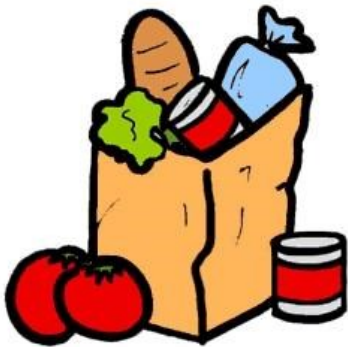

### Who can receive CSFP?

- Residents of Beaufort, Berkeley, Charleston, Colleton, Dorchester, Georgetown, Horry, Jasper or Williamsburg counties.
- 60 years of age or older
- Must meet the income guidelines created by USDA

- Contact or visit your local distribution site
- Complete CSFP application at site
- **Provide proof of age (ID)**
- **Provide proof of address (ID, bill)**

The letter must contain the complainant's name, address, telephone number, and a written description of the alleged discriminatory action in sufficient detail to inform the Assistant Secretary for Civil Rights (ASCR) about the nature and date of an alleged civil rights violation.
